Rebate Requirements

- Unit includes a **new** outdoor condenser and a **new** indoor matched evaporator coil.
- Unit is installed in a single-family or multi-family residence.
- Electric service to the residence is provided by Independence Power & Light.
- IPL must receive all information requested on the application form, including a copy of the paid receipt for the unit. The receipt must list the model numbers for the condenser, the matched evaporator coil, the expansion valve and any additional installed equipment as listed in the AHRI Directory.
- The rebate application form and receipt must be submitted to IPL within one year of the air conditioner unit's installation.
